Assignments: Attendance of lectures and a single course paper, which must be written in Tex, and must be about two pages. No other assignments.

Grading: A student's base grade for the semester will be an A if the course paper is competently written; a B if it is not competently written; a C if it is bad, and an E if it isn't turned in before the last lecture of the semester. Each lecture a student misses without an excused (in advance) absence, in excess of two, will result in a reduction of a +/- grade from the base grade. Course paper may be turned in at any point of the semester. If the paper is not deemed competently written, feedback will be provided and the paper may be rewritten, and regraded, before the last lecture on April 15.

No Final Exam: There is no final exam. The last lecture of the semester will be on April 15.
