## Math 5520 - Introduction to Topology II Spring 2021 Ken Bromberg

**Syllabus:** This course is the second semester of an introduction to topology and geometry. The main topic we will cover is the fundamental group. While I will not follow it precisely, Munkres book will be our main written source and some homework problems will come from the book. Knowing some basic group theory will be helpful, but not necessary, for the course.

**Book:** The main reference for the course will be *Topology*, 2nd Ed. by James Munkres. However, I won't always follow the book. Some homework problems will come from the book.

Grades: Grades will be based on regular homework (50%), quizzes (25%) and a final exam (25%). Homework will be done in groups. It should be written in LATEX and submitted via canvas. The quizzes will be taken during class time and the final will be a two hour exam during the classes scheduled exam time. Both the quizzes and final will be proctored with Zoom. For the quizzes and final you will need to scan your hand written answers into a pdf file so that you can submit them via Canvas.

Homework: I'm anticipating that that there will be around 8 assignments for the course (roughly every two weeks). As with all math classes doing homework is essential for learning. Homework will be done in groups of 3 to 4 and each group should turn in a single assignment via Canvas. To ensure that everyone is participating in your homework you should include the times your group or a subset of your group met along with who was in the meeting. You should also indicate who wrote up each individual problem. While it is understandable that on occasion you may not be able to participate in a group meeting, it is extremely important that you communicate this promptly to the rest of the group. If there are any issues with how your group is working together you should let me know promptly so that I can address the issue.

Quizzes: There will be short quizzes (15 minutes) approximately every 2 weeks.

Final: The final exam is May 3rd from 8:00 AM - 10:00 AM.

Format: This course is an IVC (Interactive Video Conferencing) course. We will meet via Zoom during the regularly scheduled class time (MWF 10:45-11:35). Zoom is free software that can be downloaded at zoom.us/download. You will be able to participate most fully with a laptop/tablet, microphone and webcam. I find the tablet particularly useful for using the shared whiteboard feature of Zoom or whatever drawing app that the tablet has. We will always occasionally use Google's Jamboard app. However, you only need a phone to listen.

For most classes I will lecture which I will record and post on Canvas. I will be writing on an iPad and will also post my notes. You will be able to ask questions either in the chat function on Zoom or verbally. As I will post these lectures so that anyone in the class can listen to them later (they will be deleted at the end of the course) you should not reveal any personal information during lecture.

The class will be a more effective learning experience if it is interactive so please don't hesitate to ask questions during lecture. When you are not asking a question you should keep yourself on mute so that we don't have any extra background noise. I won't insist on this but I strongly encourage you to leave your camera on during class.

We will also occasionally use class time to work in small groups on problems. Here we will use the "breakout room" feature of Zoom so that you can be split into groups. When we do this I may first record a preliminary brief lecture on the problems to get you started. I will expect that you will have watched them before class.

Office Hours: Office hours will also be over Zoom. I'll announce times after consulting with the class and post them on Canvas during the first week of classes. I'm also available to meet outside of office hours. You should send me an email to arrange a time to meet and let me know your availability in the email.
